Reduces chlorine, chemicals, odours, and volatile organic compounds (VOCs) to improve taste and safety.

Stage 3 - 0.5 Micron Anti-Scale / Fine Carbon Filter

Delivers the final purification step, reducing residual chlorine and preventing scale buildup inside taps and appliances.

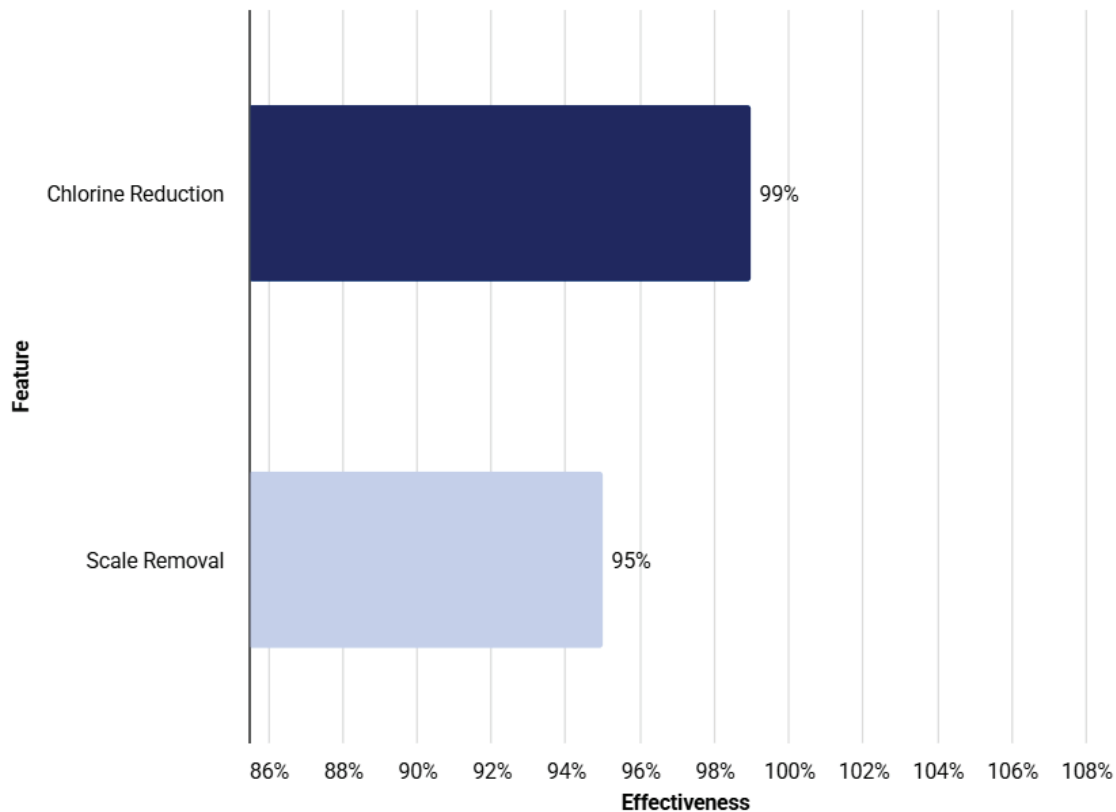


Scale and Why It Should Be Removed

Terms and Conditions

1. Payment Terms

- A \$250 deposit is required to secure a booking.
- Full payment is due on completion of the installation.
- Variations or additional works must be approved prior to commencement.
- All supplied materials remain the property of the installer until full payment is received.

2. Plumbing Compliance & Existing Conditions

- All works comply with Victorian plumbing regulations and AS/NZS 3500.
- Pricing assumes all existing plumbing, pipework, valves, stop taps, and fittings are compliant and in good condition.
- Any non-compliant, unsafe, leaking, damaged, or outdated plumbing must be rectified before installation can proceed (charged as a variation).
- The installer is not responsible for existing system faults or failures.

3. Water Pressure Requirements

- Site water pressure must be 500 kPa or below in accordance with AS/NZS 3500.
- If a Pressure Reducing Valve (PRV) is required, the cost for supply and installation is \$300 + GST.
- PRV installation is not included in the fixed installation price.
- The installer accepts no liability for damage caused by excessive or uncontrolled water pressure.

4. Water Meter Access Requirements & Installation Location

- The water meter must be fully visible and accessible, not: obstructed, buried, boxed in, surrounded by vegetation, concreted in
- The fixed-price installation includes installation on the house or within 1.5 metres of the water meter, based on the licensed plumber's assessment on the day or during a pre-installation review.
- If installation must occur beyond 1.5 metres, additional materials and labour will be quoted before proceeding.
- If concrete cutting, excavation, vegetation removal, or clearance is required, additional charges apply.
- Reinstatement of soil, turf, garden beds, or landscaping is the customer's responsibility.

5. Customer Responsibilities

- Clear and safe access to the installation area must be provided.
- The main shut-off valve must be operational.
- The customer must disclose any known plumbing issues, including: low water pressure, history of leaks, hidden damage, asbestos or hazardous materials, fragile, old, or unsafe plumbing

- The customer must monitor the installation area for 24 hours after completion and report any leaks immediately.

6. Filter Replacement & Ongoing Maintenance

- Filter cartridges must be replaced every 12 months or as recommended by the manufacturer.
- Failure to replace filters may cause: reduced flow/pressure, bacteria or microbial growth, unpleasant taste or odour, contaminants entering water, leaks or swollen cartridges, damage to housings, voiding of warranties, Issues caused by poor or neglected maintenance are not covered by workmanship warranty.

7. Variations & Hidden Conditions

- If hidden defects or concealed conditions are discovered (damaged pipes inside walls, structural obstructions, electrical hazards, rotten framing, etc.), work may be paused until rectified.
- Additional work required to complete the job safely will be treated as a variation.
- The installer is not liable for delays caused by concealed or pre-existing defects.

8. Liability & Warranty

- The installer provides workmanship warranty in line with Australian standards.
- Liability does not extend to: pre-existing plumbing faults, excessive water pressure, deterioration of old plumbing, customer tampering or alterations, incorrect filter changes, manufacturer warranty outcomes, indirect or consequential damages
- Liability is limited to re-supply of services or repair of workmanship under Australian Consumer Law.

9. Interference or Modification

- The installer is not responsible for leaks or faults caused by: incorrect filter installation, customer adjustments, moving or altering the system, unauthorised repairs
- Any rectification caused by interference is charged as a separate service call.

10. Site Attendance, Cancellations & No-Access

- If the installer attends site and cannot complete installation because of: inaccessible or obstructed water meter, unsafe, leaking, or non-compliant plumbing, no one home or no access, same-day cancellation, customer not ready for works, refusal to proceed, then \$250 deposit is non-refundable and becomes a service call fee.
- Rescheduling for any reason requires a new \$250 booking fee.
- In rare cases where we must reschedule due to unforeseen circumstances (e.g. illness, emergencies, safety issues), we will provide the next earliest available appointment.

11. Acceptance of Terms

By paying the deposit, accepting a quote, or booking an installation, the customer acknowledges and accepts all terms, conditions, disclaimers, and responsibilities outlined in this document.
